# Leaf Burning Do's and Don'ts in the City of Sandwich

Leaf burning can be a nuisance to others when not done in a thoughtful manner.

The city recently passed Ordinance 2023-14 to provide clear guidelines as to when and how leaves are to be burned.

#### DO

- Burn only dry materials dry leaves, paper, cardboard etc.
- Burn only during the hours of <u>Noon until</u> <u>6:00 p.m. or dusk</u>, whichever is earlier.
- Burn under the supervision of an adult.
- Burn only in designated areas away from structures and city Right of Way.
- Be a good neighbor be sensitive to others that may have breathing issues.
- Pay attention to where smoke is going.
- Pay attention to the weather avoid wind.

#### DO NOT

- Burn on Sundays, during the week of the Sandwich Fair, or on other Holidays.
- Burn wet materials wet cardboard, paper, rags, green leaves, grass or weeds.
- Burn on any public areas Right of Ways, streets, pavements/sidewalks, curb, parkways or alleys.

Open recreational fires are permitted outdoors in open areas. Recreational fires are to be kept within a five (5') rock or brick containment area or in an open fireplace designed for cooking.
