Secs. 2-249-2.274**Division 7-Department Heads**

The police chief, city engineer, public works director, water superintendent, streets and property superintendent and the wastewater superintendent (referred to as Division Heads) shall be appointed by the Mayor and with the approval of the city council and shall hold office for one year from and after the appointment and the qualification and until their successors shall have been appointed and qualified, provided, however, that such term of office shall not continue beyond the remaining term of the mayor.
