Mayor Olson talked about <u>Ordinance 2016-16</u> (General Obligation Bonds Tax Abatement) and presented it for first reading. This is a yearly item that comes before the council and will be presented at the December 12<sup>th</sup> regular meeting.

Mayor Olson brought up Resolution 16-09 (1% Sales Tax Increase) Resolution is requesting a referendum be submitted to voters for the April 2017 ballot. It will be brought up for questions and adoption at the November 28<sup>th</sup> council meeting.

Mayor Olson Tax Levy 2016 .7% normal tax levy corporate, pensions funds, etc. Areas that City of Sandwich levy every year. Numbers are made by Kendall and DeKalb Counties no hearing will be triggered as the number is below amount that would cause a hearing. Numbers of work-man's compensation has gone down. IMRF is funded over 100% currently. Alderman Redden asked the Mayor to tell the council what would happen if the City does not meet the amounts needed. Alderman Dell talked about City trying to catch up with the police pension fund. Mayor said they are doing a pretty good job of using some other funds that were to the plus and they have moved that over to cover some catch up with the police pension fund.

Mayor Olson talked about surplus property auction and that they need to come up with a date for the auction.

Mayor Olson requested an Executive Session for personnel section 2C1.
